#### **069/12 DECLARATIONS OF INTERESTS**

#### **070/12 ISLE OF WIGHT BESTIVAL**

Representatives from the Isle of Wight Bestival presented site plan, traffic management and noise management plans for the 2012 event.

**RESOLVED: To review the impact of the Bestival on residents of Havenstreet and Asheys immediately after the 2012 event and take action if noise and traffic issues have not improved.**

**RESOLVED: to debate at the next Parish Council meeting the possibility of the Parish Council employing agents to carry out independent sound monitoring during the Bestival 2012.**

Noise nuisance has been reported from the waste processing site off Briddlesford Road adjacent to Combley Lodge, where there is a current planning application.

This will be followed up by the Clerk with Planning and Environmental Health.
