- 19/25/26      Vacancy on Parish Council to initiate co-option process**  
Cllr A Barry, Cllr V Hattersley, Cllr C Gauntlett and Cllr M Lyons voted unanimously for Mark Wilson as a new member to The Parish council and the Acceptance of Office signed.
- 20/25/26      Parishioners Correspondence**  
The clerk announced all correspondence has been circulated to members prior to meeting.
